- To allow participants to share and exchange experience, knowledge, and information.
- To improve judging methods and practices

4 TRANSPORTATION

Competitors are responsible for their own transportation to and from the competition venues.

Local transportation may be provided upon request on the final entry form.

To be paid depending on the distance to the chosen accommodation (not included in the competition entry fee).

Judges and FAI officials who do not arrive by car will be picked up at their arrival Airport/Train station (organised upon request) Local transportation for Judges and FAI Controller will be provided during the competition.

5.1 ENTRY FEES WILL BE AS FOLLOWS (ALL IN EURO)

* the CHF sanction fee will be converted to estimated € after ISC Plenary and all NACs that have submitted a provisional entry will be notified about the applicable amount, so the whole entry fee can be paid **in one €** bank transfer.

Entry fee covers

One Official training jump

- 8 Competition jumps, Re-jumps, Jumps-off
- Opening ceremony
- Closing ceremony
- Banquet
- Closing party
- Competition Souvenir Bag

Entry Fee does not cover

- ISC sanction fee
- Accommodation, meals, transport (see below)
- Additional training jumps or after competition mixed team jumps (see 8)

Disciplines to be contested

Speed Skydiving according to ISC SP Competition Rules 2025 (i.e. including mixed team event).

5.2 ENTRY DATES

(for provisional and final registration, see SC5 4.4.1.)

- Provisional registration must be received not later than **12th June 2025**.
 - Official registration must be received latest on **12th of July 2025**
- Late registration may be accepted if capacity allows, and the entry fee will be increased by 20%

5.3 NUMBER OF COMPETITORS AND TEAMS ALLOWED

as specified in SP Competition Rules 2025. (12 competitors in total 9/3 by gender)

5.4 REGISTRATION PROCEDURE

Registration is to be made by one (NAC authorized) person only. NO individual registration.

If a NAC has amendments to the registration, **send an updated Excel file again**. (latest version will be used)

5.5 REGISTRATION PAYMENT PROCEDURE

Payments can be made within one week based on an invoice which will include bank details and will be sent together with the confirmation message after the final entry form has been submitted.

Deadlines to avoid increased entry fee as in 5.2: Final entry NLT 12th July -> Payment NLT 19th July

Any bank charges for the wire transfers will be the responsibility of the sender.

10 EQUIPMENT

10.1 SAFETY

Helmets are mandatory for all competitors.

AADs are required.

Fully opened parachute must be at minimum of 600m AGL.

Reserve Parachute Repacks according to each participant's national regulations.

10.2 LEGAL REQUIREMENTS

A skydiving licence which is valid to jump in AUSTRIA is required by Austrian law. Not all national licences are accepted automatically and need to be validated latest at the registration office.

In case of doubt, contact the organiser in advance.

For 3rd party liability insurance see 14 Insurance Details

10.3 FAI SPORTING LICENSE

A valid FAI Licence for 2025 is required, and each competitor must be listed in the FAI Sporting License Database prior to final registration deadline (see 5.2.)

ISC approved scoring systems will be used (Flysight and Intime)

13 MEDICAL / EMERGENCY DETAILS

Personal medical & repatriation is the responsibility of each participant, any **costs associated with medical care are to be covered by the concerned participant.**

2025 ISC regulations regarding FAI/ISC Injury Protocol will be applied.

14 INSURANCE DETAILS

Medical & repatriation insurance is recommended, but not mandatory.

Third party liability with coverage for situations not covered by SC 5, 4.5.3 (2) is required by Austrian law, the required minimum coverage is **€ 1.5 million Euro**.

If requested together with the final entry, the organiser can assist with contacts to national insurance providers.
